November Showcase TM Hanna


T M Hanna is no stranger than or to the Folk Club audience. His first showcase took place several years ago, shortly after then president Larry Mediate came up with the idea. At that showcase he played mountain dulcimer, harmonica, pennywhistle, guitar, banjo, and mandolin. He travels much lighter these days and has since performed at the Folk Club way too many times, both as a solo performer and in various and sundry combinations with other musicians. T M currently plays as part of the ensemble Pete Brown and the Mad Cows, in which he plays mandolin and occasionally harmonica. Their repertoire spans four decades and several different genres. They can be heard (or is it herded?) in smoky pubs in the Northern Virginia area. Joining T M on will be guitarist Mike Wilkinson his compatriot in the Mad Cows.

When asked if he hoped for a large turnout, T M admitted, "It always nice to play for a big crowd but

around here it sure slows down the beverage delivery system." T M records exclusively for Birdphluph Music (mostly because nobody else has asked.) His CD *Good Things Take Time* was still available as of press time.

Native Washingtonian Paul Watson is a harmonica player, singer, and songwriter, whose playing favors country and Chicago blues with a little jazz thrown in for extra measure. He also plays mandolin in the string band tradition. He has shared the stage with the likes Kids are two of their educational creations. of Pinetop Perkins, Saffire--the Uppity Blues Women, West Virginian Bluesman Nat Reese and, most recently, National Heritage Artist Howard Armstrong. Paul's mastery of blues harp has made him a sought-out session recording artist. He has taught and performed blues harmonica at the award-winning Augusta Heritage Workshops' blues program in West Virginia.

Judy Luis-Watson grew up in a musical family in Tanzania, East Africa. Playing by ear and studying piano as a child, she began performing in the late '60s with her sister as a piano-percussion-vocal duo. At Carnegie Hall's 1992 Folk Festival, she performed Southern African folk songs with Nomonde Ngubo. Judy is especially inspired by blues pianists and singers Otis Spann and Jeannie Cheatham. She has teamed up with Gaye Adegbalola (of Saffire: the Uppity Blues Women), providing piano accompaniment for blues vocals at the Augusta-Heritage Workshops in West Virginia and other events. Judy plays piano on Gaye's educational video, "Learning to Sing the Blues," produced

by Homespun Tapes in 1997. Judy teaches blues piano and has taught at the Swannanoa Gathering in North Carolina. In 1991, she was nominated by the DC Commission on the Arts for a Mayor's Arts Award. Their partnership with guitarist Akbar Sharrieff rounds out the trio.

Paul and Judy formed BluesWorks in 1991. They have produced several recordings including their debut CD Far From Home. They have recorded with other artists and may also be heard on Augusta Heritage Workshops' sampler recordings. A multimedia presentation, The Blues Connection: The Music, Stories, and Pictures of Legendary Blues Artists and their interactive program, Blues Songs and Rhythms for

On most nights, the Folk Club is an open mike format with a sign-up board. Each performer gets 12 minutes, including setup time (about 3 songs, usually). A \$1 donation is requested.

Showcase Performances

On the second Tuesday of each month, we feature a Folk Club member in a two set (25-minute) "Showcase" performance. To be in a showcase all you have to do is:

- be a Folk Club member (who hasn't done a showcase in 6 months)
- fill out a lottery slip any time in the month before the drawing
- win the drawing (held on the night of the previous month's showcase); and
- practice, practice!
